Position Objective: Provide nutrition education to the participants of the Spirit Lake Food Distribution Program clients throughout the year and coordinate activities within the parameters of the FY-18/19 Special Nutrition Education grant award.

Major Duties & Responsibilities

- Performs duties specific to the goals and objectives identified in the Food Distribution Program Nutrition Education grant. This may include training attendance, community education, garden management, youth camp management, and collaboration with related programs and agencies.
- Works as a team with the United Tribes Technical College staff to develop and deliver educational programs that meet the needs of Tribal communities served by FDP, including nutrition education.
- Provides nutrition and wellness exhibits, classes and programs for youth and adults.
- Participates in community activities with planning groups to promote nutrition and wellness for FDP participants.
- Communicates with Tribal organizations, agencies, and other educational institutions to meet FDP grant goals and objectives.
- Must be a self-starter
- Attends meetings related to project goals and objectives.
- Provides progress reports to FDP Director and other collaborative agencies as needed.
- Seek grants to enhance the Nutrition Education department.
- Other duties as assigned.

WORKING CONDITIONS:

General office conditions and outdoor garden work. Normal work week is 40 hours following Spirit Lake Sioux Tribe policy. Work assignments may require occasional evening or weekend work, based on scheduled assignments and community classes. Some overnight travel may be required for training or presentations and conferences.

SUPERVISION EXERCISED:

Dependable and organized to plan and coordinate scheduling of nutrition education sessions, supervision of part-time temporary assistants may be required.

MINIMUM QUALIFICATIONS:

Registered dietician or bachelor's degree with related experience in the areas of nutrition, RN/LPN, Education, Social Work or Allied Health Programs.

OTHER QUALIFICATIONS:

- Work experience with Native American communities, agencies and institutions of higher education.

- Possess good oral and written communication skills.
- Valid driver's license.
- Ability to establish working relationships and presentations with/to Tribal officials, collaborative partners, and other agency representatives.
- Must pass a pre-employment drug test and will be subject to random drug testing.
- Must possess and maintain a valid Class D Driver's License and have reliable transportation.
- Subject to background check.
- Excellent written and verbal communication skills.
- Friendly, customer-orientated personality.
- Ability to physically perform the essential functions of the job and be able to lift 50 pounds.
