DIVORCE INFORMATION SHEET

This information sheet and forms can be used when you want to file for a divorce by yourself and cannot afford an attorney. Read this information sheet carefully to help you.

The Spirit rake Tribe refers to North Dakota law as guidance when deciding issues surrounding a divorce if and when those issues are not governed by express law under the Spirit Lake Tribal Code of Law and Order. You and your spouse (husband/wife) must have irreconcilable differences to get a divorce. That is to say that there must be no way to make your marriage work. You must also have been a resident of the State of North Dakota and/or the Spirit Lake Reservation for a period of more than 6 months prior to the entry of the divorce by the Spirit Lake Tribal Court.

Use the Divorce Petition form to ask the Spirit Lake Tribal Court for a divorce. Answer every question as completely and thoroughly as possible. Any information that is not contained in the divorce petition in or Answer will not be addressed by the court so be sure to include all the requested information. In the event that any section of the Petition or Answer does not apply to your circumstances please indicate that by writing "NOT APPLICABLE" in the blank space provided. Your name should be written on the line that indicates "Petitioner". Your spouse's name should be written on the line that indicates the word "Respondent" on top of the summons page and the divorce petition page. Fill in all blanks or write the words "not applicable" by any question that does not apply to you. Some questions allow you to choose the correct words such as (am/am not). Circle the words that you want to use.

If you are confused by the form or have any questions, ask for help. When you finish, ask the Notary Public to watch you sign the forms and have the Notary "Notarize" our signature. Take these forms along with a money order or certified check in the amount of \$150.00 which is the Filing Fee, to the Clerk of Court who will make sure that your spouse gets a copy of the divorce forms. However, you must provide to the court information as to the whereabouts of your spouse and a current address. We cannot process the papers unless we know where the other party is and if they have received notice of these proceedings.

After the documents have been served upon your spouse, the Clerk will inform you by mail when your divorce hearing is scheduled. A court date will be determined dependant upon the court's docket schedule. You MUST appear in court on the scheduled hearing date to personally ask the Judge for a divorce and to answer any questions that the Judge may have.

Your spouse MAY appear in court at the hearing date, but is not required to unless they wish to contest or disagree with anything that you are asking for in your divorce papers.

When your case is called, the Judge will ask you to swear you in to begin to provide testimony to the Court. You must answer all questions clearly and state the facts about your marriage. Also tell the judge what custody and property settlement you would like or read from your papers. Answer the Judge's questions as well as you can. Also you should bring in any receipts for property that you may have and you should also bring proofs of any debts that you may have. If your spouse or any other witnesses show up to oppose you, the Judge will decide if you should go to an attorney before the hearing will be held.

SPECIAL INSTRUCTIONS REGARDING FORMS

Before you begin to fill out your paperwork decide whether you are asking the Court to decide on child custody as part of your divorce, then follow the instructions below on the previous page when completing your paperwork.
