## Spirit Lake Tribe Education Incentive Application

**All incentives are not guaranteed and will be determined on available funding**

- ◆ The Tribal Education Program will only pay for incentives from the program within the current fiscal year: Fall, Spring, and Summer semesters.
- ◆ Must be an enrolled member of the Spirit Lake Tribe. **Proof must be provided.**
- ◆ Due to confidentiality, **NO information will be released to any person other than the student, unless the student has provided written consent to release information to a designated person.**
- ◆ The college students and dual credit students **must maintain a 2.0 GPA to be eligible for final grade payments.**
- ◆ In order to qualify for dual credit/college credits final grade payment, the student **must have a "C" or better letter grade.** If the student has a failing grade he/she will not be eligible for the dual credit/college credits final grade payment for the failing course.
- ◆ The Spirit Lake Tribe will not be responsible for any outstanding debt owed to the college or university that the student is attending. The debt will be the responsibility of the college student.
- ◆ The Spirit Lake Tribe will not be responsible for deposits or fees that may occur from the College for the dual credit course (s)/ College courses
- ◆ No advances or loans against the funds will be permitted to any student.
- ◆ Boarding school, GED/Certification students: These students will be assisted as funding is available. The maximum amount to be received is \$200.

### ◆ **HIGH SCHOOL & MIDDLE SCHOOL HONOR ROLL INCENTIVE:**

Enrolled members in high school and middle school who are on the honor roll may receive the following each quarter, if he/she is on the honor roll. The school will provide honor roll report. Disbursements of incentive payments will be determined on available funding.

A Honor Roll	9th — 12th Grade	up to \$100
B Honor Roll	9th — 12th Grade	up to \$50
A & B Honor Roll	5th — 8th Grade	up to \$25

### ◆ **8th Grade — High School — GED CERTIFICATE INCENTIVE**

A copy of diploma or certificate must be provided before incentive will be paid. GED certificates must be submitted NO later than six months after completion. Enrolled members who graduate from high school, eighth grade, or received GED may receive the following:

8th Grade	— up to \$75
High School	— up to \$200
GED	— up to \$200

#### ◆ **High School / Early Entrance Courses**

The student must provide the transcript from the college that they earned their dual credits during high school. Once enrolled in a college/university and proper documentation is provided to show their dual credits are counted towards their degree they're seeking then the student will be allowed the following:

Grade A	\$50
Grade B	\$40
Grade C	\$25

#### ◆ **Boarding School Students:**

Eligible enrolled members may receive check/purchase order in the maximum amount \$100 per semester. Boarding school will provide student enrollment for each semester.

#### ◆ **Final Grade Incentive:**

Students that are eligible will receive the following incentive after each semester. (Fall, Spring, & Summer)

#### **College Students seeking an Associates, Bachelors, Masters or Doctorate Degree:**

Grade "A"	\$200 per letter grade
Grade "B"	\$150 per letter grade
Grade "C"	\$100 per letter grade

⇒ Technical / Vocational Schools will utilize the conversion of quarter hours to semester hours—(quarter hours' x 0.666)
