Position Objective: Act as a member of the EMS Team and provide BLS care to patients while working within your scope of practice and Standing Order & Protocols.

Major Duties & Responsibilities:

- Respond to all calls with urgency from dispatch via radio, phone, or walk in, be out the door within 1 minute during the day and 3 minutes during night hours(9pm-7am)
- Work as a member of the EMS Team and be able to take Team Lead on calls
- Operate the ambulance in a safe manner
- Monitor communication equipment to maintain contact with dispatch, driver, hospital, Medical Director, on-line medical direction, & other entities.
- Maintain all vehicles, medical, & communication equipment in good working order and cleanliness. Report all findings to EMS Manager
- Maintain and stock all equipment and supplies at the beginning of each shift and following each ambulance run. Notify EMS Manager of supplies needed.
- Complete all Patient Care Reports prior to leaving shift. These must be entered into State program and possess all mandatory signatures and information needed.
- Attend regular and special staff meetings of the Spirit Lake EMS
- Assist and direct all housekeeping duties to maintain a clean working environment
- Administer treatment to any and all persons in need of medical or trauma care, within your scope of practice

Qualifications, experience, and education required:

- Must possess a current North Dakota EMT License
- Must possess a current National Registry EMT Certification
- Must possess a valid ND driver's license and insurable under the SLT's driving guidelines and maintain License throughout course of employment.
- Must Possess and maintain BLS CPR or its equivalent.
- Must Possess or obtain ICS 100, 700, 800 within 90 days of hire.
- Exhibit a high level of personal integrity and ethical conduct
- Must be able to pass background investigation and is required to be fingerprinted.

- Annual medical evaluation physical by your personal physician and maybe subject to physical for mobility as requested by supervisor.
- Must participate in scheduled trainings
- Maintain compliance with HIPPA laws
- Must follow SLT Alcohol and Drug free policy and participate in drug/alcohol testing and (pre-employment, baseline, and Random)
- Additional duties as assigned
